

## AFFIDAVIT

I, Dongping Zhu, currently living in 9426 46TH Ave Elmhurst, NY 11373 MAKE OATH AND SAY THAT:

1. My name is Dongping Zhu, born on October 8, 1977 in Jiangxi, My Chinese passport number is E42502410. I currently live in 9426 46TH Ave Elmhurst NY 11373, having escaped from China in July 2016.
2. I have been, since the year 2009 a member of The Church of Almighty God (CAG), a Christian church whose members are severely persecuted in China.
3. I hereby declare that I am personally aware of the circumstances of a CAG Christian, whose name is Rao Jianxing (alias Su Zhen), born on February 22, 1966, in Xiushui County, Jiangxi Province, China. She is one of my church friends. I got to know her in 2010 and performed duty together for some time.
4. On August 21, 2015, Ms. Rao Jianxing was arrested by the CCP police, for the sole reason of being a member of CAG and proselyting on its behalf.
5. For the sole reason of being a member of CAG and a missionary on its behalf, she has been sentenced by the Court of Xiushui County, Jiangxi Province, China, to 22 months of imprisonment, on the charge of "sabotaging the implementation of the laws by utilizing evil religious organizations," and fined of 4,000 RMB, on April 15, 2016. She was detained in Jiangxi Women's Prison, from the date May 20, 2016 to the date June 22, 2017. And the provision of Article 300 of the Chinese Criminal Code was applied.
6. Several days after Rao Jianxing was arrested by the CCP police, I happened to go to their church for a meeting. The church leader and other brothers and sisters told me something about her story. Rao was followed by the CCP police when she went to pick up a young sister. Later, she and eight or nine other brothers and sisters were arrested by the police one after another. After fleeing overseas, I received an article wrote by Rao about her

experience of being tortured by the CCP police, from which I knew some details about what happened to her after she was arrested:

In the police station, the police officers asked her to identify other Christians based on their photos and give them the information about the church. She refused, then the police slapped her viciously across the face for a whole day, which resulted in the teeth in her upper jaw loosening. The police officers also had her armswrenched behind her back in the "airplane cuffs," and tied one end of rope to the links of her handcuffs, another to the rail under the "tiger bench", then the policemen ruthlessly trampled the middle of rope. The pain made her pass out several times. The police woke her up using mineral water and continued to interrogate her. Two pieces of flesh were torn off from her wrists due to the teeth of the cuffs. The police also slapped her face with the sole of a slipper and stamped on her toes with their leather shoes. They had been interrogating her for three days and ended up with no results. Later Rao was sentenced to 22 months in prison on the charge of "sabotaging the implementation of the laws by utilizing evil religious organizations," and then she was sent to the Jiangxi Women's Prison to serve her term. She was set free in June 2017. Not long after Rao's upper jaw was hurt by the police, she began to lose her teeth and couldn't chew food as normal. Until now she hasn't recovered yet and even needs a straw to drink warm water. The police still try to control Rao in their hands. In order to escape from the control of the CCP, she had no choice but to move home and began her life in exile.

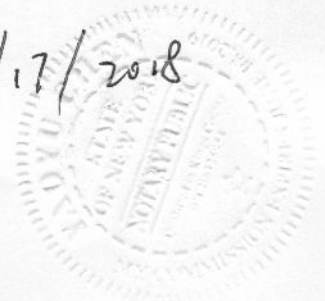
