

# Report of the Working Group on the Universal Periodic Review\*

## France

Addendum

Views on conclusions and/or recommendations, voluntary commitments and replies presented by the State under review

- 1. France is deeply committed to the universal periodic review. This unique process not only enables each State to give an account of the measures it has taken to improve the human rights situation in its territory and evaluate remaining challenges, but also to share examples of good practice and make recommendations to other States. France considers the universal periodic review to be an essential tool, whose follow-up and recommendations are of a continuing nature. With this in mind, France will submit a midterm report in 2015 on the implementation of the recommendations made during the universal periodic review in January 2013.
- 2. France has carefully considered the 165 recommendations it received. All of the ministers concerned participated in the drafting of the replies to the recommendations and the National Consultative Commission on Human Rights was consulted during the process.
- 3. This addendum is divided into several parts. It is supplemented by an annex explaining the positions taken by France in respect of each of the recommendations.
- 4. France accepts the recommendations whose wording and intention it supports, as well as those it has already implemented.
- 5. France does not accept the recommendations that it is not in a position to implement for legal or constitutional reasons, whose content it does not support, or whose claims it rejects.
- 6. France has not responded to the recommendations on subjects that do not fall under the scope of the universal periodic review.
