## Introduction - Migrants' Rights and Digital Freedom

- Despite commitments, Saudi Arabia has failed to implement meaningful reform regarding Migrants rights and Digital freedom
- Migrant workers endure exploitation and abuse, despite assurances of reforms to improve their conditions.
- Digital freedom of expression faces continual suppression, stifling dissenting voices in online spaces.

# Migrant Rights Concerns


- Saudi Arabia accepted 15 recommendations in which promised to **support** and **promote** and **strengthen** migrants rights.
- Saudi Arabia maintains a restrictive kafala system despite pledges for improvement.
- Migrant workers face ongoing exploitation, unpaid wages, and severe violations.
- Arbitrary detention and deportation of Ethiopian migrants persist.

# Digital Freedom of Expression

**Recommendation 138.53:** Bring its domestic legislation in line with the rights to **freedom of expression**, association and assembly, and to enact and implement a law of association enabling all NGOs to operate legally, without harassment and undue government interference

- Saudi Arabia's unmet commitments
- **Mohammed Al Ghamdi**, a teacher, arrested and prosecuted for expressing opinions on social media.
- Prominent journalist **Jamal Khashoggi** murdered in October 2018 within the Saudi consulate in Istanbul.

# Human Rights Violation

- Extensive state-sponsored spying, illegal data access, and spyware usage to track and censor dissenters within and outside Saudi Arabia.
  - Activists persecuted under Anti-Cybercrime and Counter-Terrorism Laws for criticizing the government.
  - Many forced to adopt anonymous online identities due to crackdowns, offering limited protection against state persecution.
- 
- Ongoing exploitation and abuse persist despite proposed reforms within Saudi Arabia's stringent kafala system.
  - Migrant workers continue to face challenges such as unpaid wages, severe violations of their rights, and arbitrary detentions.
  - Saudi border guards have been implicated in tragic incidents resulting in deaths and abuses among Ethiopian migrants endeavouring to cross the Yemen-Saudi border.




# UPR Recommendations and Failures

The **failure of Saudi Arabia** to implement pledged UPR recommendations pertaining to migrant rights and freedom of expression demands immediate attention and robust action.

ADHRB underscores the pressing need for **tangible changes** in policies and practices

# Calls for Action

- Abolish the kafala system, granting workers independence from employer constraints.
  - Eliminate exit visa procedures to ensure the unrestricted right to exit the country.
  - Urgently cease all surveillance operations and persecution of individuals.
  - Respect the right to privacy for all citizens and residents.
  - Implement previously committed recommendations (e.g., 138.116, 138.31, 138.53, 138.199) regarding migrants' rights.
  - Demand the release of individuals arrested for peaceful online expression.
  - Abrogate content-based offenses outlined in Articles 3 and 6 of the Anti-Cybercrime Law.
