1. Albania is deeply committed to the United Nations Universal Periodic Review (UPR), one of the most accomplished mechanisms to ensure a comprehensive review of each State's compliance with its international human rights obligations. It demonstrates the essential role of multilateralism and the United Nations in upholding international law, human dignity and peace. As an elected member of the Human Rights Council for the period 2024–2026, Albania will remain committed to ensuring that the UPR is a mechanism that produces concrete results for the States under review as well as for the States that make recommendations. Albania has specified in the annex of this document its national position for a significant number of the recommendations and reiterates its full commitment to the follow-up and implementation of the recommendations made in November 2024. All relevant institutions and independent authorities will be involved in this follow-up process.

2. A total of 253 recommendations were made during the interactive dialogue held on 4 November 2024. Albania has examined all recommendations made, in accordance with the provisions of Council resolution 5/1 and Council resolution 16/21.
