**Intervention on the Adoption of the Outcome Document  
of the Universal Periodic Review of New Zealand**

24 September 2009

Mr President,

The Women's International League for Peace and Freedom (WILPF) welcomes this opportunity to speak on behalf of our section<sup>1</sup> and four other national NGOs in Aotearoa New Zealand<sup>2</sup>.

We note with appreciation the recommendations made during the UPR; and New Zealand's acknowledgement that while it takes its human rights commitments seriously, there are still areas where improvement is needed.

We are particularly disappointed by New Zealand's lack of support for several human rights instruments<sup>3</sup>, and by the inadequate reasons it has given for its failure to support them. We therefore urge New Zealand to move quickly to ratify the Migrant Workers Convention<sup>4</sup>, ILO 169, and the ICESCR<sup>5</sup> Optional Protocol; and to announce its full support for the United Nations Declaration on the Rights of Indigenous Peoples.

We remain extremely concerned at the lack of full protection for human rights under New Zealand's current constitutional arrangements<sup>6</sup>. While this lack of protection is dangerous for all New Zealanders, it is particularly harmful for hapu and iwi Maori because New Zealand governments do not hesitate to deny their rights in favour of the rights of others when they perceive this to be to their political advantage.

We therefore reiterate the recommendations of the UPR, as well as earlier recommendations from treaty monitoring bodies and Special Procedures, and urge New Zealand to begin a process of constitutional change that will give full effect to the Treaty of Waitangi, as well as to its obligations under the international human rights instruments.

We urge New Zealand to develop alternatives to imprisonment for persons convicted of all but the most serious offences. Shipping containers are not appropriate housing for prisoners.

We call on New Zealand to reconsider the pending legislation<sup>7</sup> which lowers the age of criminal responsibility of twelve and thirteen year old children; and to clarify its response to the recent public referendum on Section 59 of the Crimes Act<sup>8</sup>.

Finally, we urge New Zealand to move rapidly towards achieving full gender pay equity, to ensure that women are well represented in decision making positions in all sectors of society, and to increase its efforts to reduce violence against women.
