> > **IRAQ**

Mr. President,

Amnesty International remains deeply concerned about ongoing and past human rights abuses carried out with total impunity. It is urgent to address the problems faced by the thousands who are internally displaced by the conflict. However, it is equally important for the government to rein in Shi'a militias and hold them to account for the abuses they have committed, including dozens of cases of extortions, abductions, and killings of Sunni civilian men documented by Amnesty International. Several States called on Iraq to eliminate the militias and other armed groups fighting alongside government forces.<sup>2</sup> Amnesty International calls on Iraq to act on these recommendations.

In the past year, Amnesty International has gathered evidence pointing to a pattern of extrajudicial executions of detainees by Iraqi government forces. Air strikes launched by government forces against ISIS-controlled areas have also killed and injured dozens of civilians, some in indiscriminate attacks. Several States urged the government to quarantee respect for international humanitarian and human rights law during military operations. 3 We call on Iraq to act on these.

A long-standing issue that remains unaddressed is the rampant use of torture and other ill-treatment of detainees in order to extract confessions. In many cases such confessions are used as the sole evidence to sentence individuals in grossly unfair trials, sometimes to death. Several States called on Iraq to stop the use of torture and other ill-treatment, 4 to investigate allegations of torture, and to ratify the Optional Protocol to the Convention against Torture and Other Cruel, Inhuman and Degrading Treatment or Punishment. 5 Amnesty International calls on Iraq to act on these.

Regrettably, Iraq is one of the leading executioners in the world. Since the death penalty was reinstated in 2004, at least 689 people have been executed, including at least 431 since Irag's last UPR in 2010. Amnesty International calls on Irag to act on recommendations put forward by twenty states to establish a moratorium on the death penalty.6
