- 1) SCPCRs have been constituted in all States (except Jammu & Kashmir). However, only 9 States have duly appointed a Chairperson as well as all the six members to the Commission. These are the states of Bihar, Chhattisgarh, Goa, Karnataka, Kerala, Punjab, Tripura, Uttar Pradesh and Uttarakhand.
- 2) In Haryana and Tamil Nadu, the position of Chairperson is vacant while all the six members have been appointed.
- 3) In Maharashtra, Mizoram, Telangana, Puducherry and Lakshadweep, Secretary of the nodal Ministry has been given additional charge of Chairperson, SCPCR.
- 4) Among the UTs, only Delhi, Chandigarh and Andaman and Nicobar Islands have not appointed secretaries as the members or the chairperson.
- 5) None of the UTs have a fully functioning Commission.
- 6) A total of 19 states and 3 UTs have notified rules under CPCR Act. 14 SCPCRs are functioning without any Rules.
