

ADVANCE QUESTIONS TO CAMEROON (SECOND BATCH)

GERMANY

- In the past, repeated allegations for violating human rights have been made against the **security forces of Cameroon**. How does the government ensure that human rights standards are met by the **police and the military**?
- What position does the Cameroonian government have towards **international criminal law**? Will there be any steps to **ratify the Rome Statute** in the near future?
- The **humanitarian situation in Cameroonian prisons** has worsened in recent years due to progressive overcrowding. What measures is the Cameroonian government planning to improve in the short and medium term?

UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND

- What steps has the government of Cameroon taken to complete an investigation into security forces' handling of peaceful student protest at the University of Buea on 29 November 2016, to hold to account those responsible and to support victims?
- What steps will the government of Cameroon take to address human trafficking, particularly of young women, for forced labour and sexual exploitation?
- What steps is the government of Cameroon taking to ensure fair trials for Anglophone detainees and separatist leaders extradited from Nigeria who have been held incommunicado since January this year?
- What steps is the government taking to promote freedom of expression, including improving access to information and ensuring a free media.

- Comment le gouvernement Camerounais garantit-il la liberté d'expression sur Internet dans tous les régions du pays ?
- Le gouvernement Camerounais compte-t-il continuer la pratique du moratoire de facto sur l'exécution de la peine de mort, y compris en cas d'application de la loi anti-terroriste?
- Quelles mesures le Gouvernement Camerounais prend-il pour mettre fin à l'escalade de violences, aux arrestations arbitraires et aux mauvais traitements imputés à des agents de l'Etat dans les zones anglophones du pays, et pour assurer que, après une enquête indépendante et impartiale, les personnes responsables soient poursuivies en justice et que les victimes obtiennent réparation ?
