

## **ABOUT THE AGREEMENT OF GENOCIDE OF MACEDONIA AND THE MACEDONIANS**

**(The Agreement between Macedonia and Bulgaria, Macedonia and Greece signed on  
August 1, 2017 & 17.07.2018)**

### **Regarding the Agreement of the Republic of Macedonia with Bulgaria**

On August 2, 2017, the Republic of Macedonia, and Macedonians under the pressure of the European Union, and in the presence of the army of the United States of America, in the Republic of Macedonia, despite the disagreement of the Macedonian ethnic people, in anticipation of one of the holiest holidays from the struggle of the Macedonian people for freedom from the fascists in the Second World War, on August 2, Ilinden, under the strong assassination of the police with armored and heavy vehicles, with the isolation of the almost 500 m -1 -mile around, with beating and binding some Protestants

Prime Minister Zaev signed a "Treaty of Genocide" of the Macedonian people with Bulgaria with which he renounced the Macedonian minority in Bulgaria and signed an agreement to build a common history (negation of cultural AND HISTORICAL identity) by interfering with Bulgaria contrary to the Constitution, with derogation of the international human rights and freedoms rights of the Republic of Macedonia and Macedonians.

At 17 June 2018 Prime Minister Zaev and minister Dimitrov signed again a "Treaty" with Greece in the presents of EU representativs as Federika Mogerini, with which he renounced the Macedonian minority in Greece and signed an agreement to build a history under Greece rules and writings, by interfering, contrary to the Constitution, with derogation of the all international human rights and freedoms of historical and cultural and ethnic identity of Macedonians and Republic of Macedonia.

With this Agreement contrary to the self-determination of the Republic of Macedonia for its constitutional name and against the self-determination of the ethnic Macedonians for their identity - Macedonians, they negotited for the addition of adjectives and adverbs of geographic region to the identity of the ethnic Macedonians and Macedonians to declares them in all personal documents as "Macedonians - Citizens of the Northern Republic of Macedonia" and Macedonia as the Republic of North Macedonia.

The agreement is also unfounded to the law, there are no basic elements of the Agreement, it is a poor, one-sided, (no name of other party?), Under compulsion, extorted, perhaps with other defects in the will, without the protection of interests on both sides, immoral, contrary to the Constitution, laws and international human rights law, that is, violates all the provisions of a positive law.

This Treaty is contrary to and violates all the principles and values of the European Union and the United Nations based od basic human rights and freedoms.

In general, it can not be called an Agreement, but it is more a ORDER and Capitulation without war. Deleting the identity of ethnic Macedonians with pencil.

**The agreement is simultaneously totally illegal and injustice, genocide and fascist due to denial of the right to self-determination of a state and ethnicity based on the UN Conventions on Human Rights, as well as the Universal Declaration.**

**Argument/fact:** The Agreement with Bulgaria and Greece signed by the Government of Macedonia.

**From the three known points of this Agreement with Bulgaria,** it is obvious that the treaty must be annulled, specially as concerned the Article 8, Items 2 and 3 (inferior). The first point of this Article is not disputed.

**From the known points of this Agreement with Greece, it is obvious that the treaty must be annulled fully,** specially as concerned The Preamble where the Republic of Macedonia does not exist under the name determined in the Constitution and does not have its name at all, each of the items in Article 1,2,7 where is a complete and absolute violation of the provisions of international law for human rights and freedom of self-determination of every person and the same right for the State. **All these articals entail the nullity of the entire agreement**

The internal affairs of sovereign states and nations, such as identity, culture or history, and human rights and freedoms, in the case of the Republic of Macedonia and the Macedonians as a ethnic nation, must not be subject to an Agreement of any Governments and organizations , especially to the Government of another neighbouring State which denied all rights of identity and language – these Rights of different states are not common and they will never be, neither other State can determinate identity of citizens in Macedonia.

1. Those Agreement, which the Government of the Republic of Macedonia sign with the Government of Bulgaria and Greece , are direct violation of the Constitution of the Republic of Macedonia and the International Human Rights Law, as follows:

The Constitution of the Republic of Macedonia

Article 8, Paragraph 1, Lines 1, 2, 3 and 11; Article 24; Article 25; Article 28; Article 51; Article 54; Article 118, as well as

2. Direct violation of the provisions of the International Covenant on Civil and Political Rights and the International Covenant on Economic, Social and Cultural Rights, in force of the Constitution in the Republic of Macedonia,

3. Violation of the Universal Declaration of Human Rights.

### **Towards Lines 1, 2 and 3**

The Constitution of the Republic of Macedonia provides, as fundamental values of the constitutional order of the Republic of Macedonia, the following principles in Article 8, Paragraphs 1, 2, and 3 and 11:

- The fundamental freedoms and rights of the individual and the citizen recognized by the international law and established by the Constitution; the free expression of

nationality, the rule of law; respecting the generally accepted norms of international law.

- Pursuant to Article 118 of the Constitution, international treaties ratified in accordance with the Constitution are part of the internal legal order and can not be changed by law.
- Regarding these provisions of the Constitution, the International Covenant on Civil and Political Rights and the International Covenant on Economic, Social and Cultural Rights of the United Nations, as one of the basic international human rights law documents, signed by almost all countries in the world, as ratified by the side of the Republic of Macedonia, has a Constitutional force and can not be changed by law or other regulation.
- Since the defense of the Republic of Macedonia, in accordance with the Article 28 of the Constitution, is the right and duty of every citizen and, above all, of those to whom the citizens have transferred sovereignty in accordance with the Article 2 of the Constitution, and Macedonia is a fully sovereign and independent state in accordance with the Article 1 of the Constitution.
- This obligation, to respect the provisions of the Constitution and the International Human Rights Law, is particularly mandatory for any Prime Minister, Government or Minister of Foreign Affairs, and they should consider them as a right and duty to defend this sovereignty and to consider all possible consequences in connection with the elements of the international human rights law when signing any agreements on behalf of the Macedonians, the Macedonian citizens and Macedonia as a state.
- If they allow the interference of another state, in the fundamental human rights and freedoms of any of their citizens that are a distinctive constitutional nation, they automatically deny the sovereignty of the Republic of Macedonia, put Macedonia under occupation, its independence, its uniqueness, as well as the particularity of the Macedonian people and the nation, the right to self-determination and free development of culture and history – a violation of all the already stated articles of the Constitution.

Furthermore, in conjunction with the Articles 51 and 54 of the Constitution of the Republic of Macedonia, laws must be in accordance with the Constitution, and all other regulations (including the conclusion of Contracts) with the Constitution and law. Everyone is obligated to abide by the Constitution and the laws.

Is this the case with this agreement with Bulgaria and Greece? No, it isn't.

**Regarding Article 20 of the Constitution of the Republic of Macedonia, this behavior of the political parties in the Government is, again, even additional, violation of the Constitution because: firstly, the programs and the activities of the associations of citizens and political parties can not be directed towards violent destruction of the constitutional order of the Republic and to encouraging or calling for military aggression or incitement to national, racial or religious hatred or intolerance; and, second, this agreement with Bulgaria and Greece definitely created such a climate and**

**sparked hatred and intolerance not only nationally but also regionally.**

**The worst thing is that Federica Mogherini, on behalf of the European Unions like Stoltenberg for NATO give greetings and support to those agreements even though this Agreement is FULL OF DEROGATION OF THE INTERATIONAL HUMAN RIGHTS LAW, and today 12.07.2017 Stoltenberg declared – If you don't change name you will not enter to NATO!**

**The most crucial fact is hidden genocide on other way– the Bulgaria, after entering the European Union, have used the situation of isolation and poverty of the population in the Republic of Macedonia to sell passports to the Macedonians with a simple statement that they are Bulgarians (genocide and assimilation), for the price of 500-700 Euros, and the Macedonians, in poverty, buy those passports, so that they can go to Europe, travel freely and work.**

In this way, nowadays, and in the past, Europe has stood on the side of fascism and has supported genocide over Macedonia and the Macedonians.

We send you online evidences of the existence of the assimilation of the Macedonians, that is a hidden form of bulgarization of the Macedonians through the Bulgarian passports; namely, it is claimed that there are more than 100,000 Macedonians by ethnic origin and others from the minority communities who declare that they are Bulgarians bypassing the sole purpose of leaving Macedonia because of the closed borders, i.e. the postponement of admission to the European Union and poverty.

The demand for the change of the constitutional name is another form of genocide and racism that is taking place alongside the Bulgarian passports.

## **ALBANIA AND ITS INTERFIRANCE IN THE MACEDONIAN IDENTITY**

At the same time as the above mentioned, the representatives of the Albanian political parties in Macedonia – BESA, DUI and the Alliance of the Albanians and under the auspices and support of the Prime Minister of Albania Edi Rama, in Tirana, outside of Macedonia, use the instability of Macedonia and the inability to form the Government of the new majority, after the long regime of Gruevski's autocratic rule, signed a Platform which is a criminal act committed under the Criminal Code of the Republic of Macedonia, and a breach of the International Human Rights Law, and they demanded rights of a state-based people, that is, linguistic equality, and a change of the state symbols with the equal use of the Albanian ones, as well as participation in the name negotiations, i.e. solving the fate of the ethnic Macedonians.

The official language of the whole territory of the Republic of Macedonia is Macedonian, and the Albanian is official only for the Albanian minority, at their request, and in the Municipalities i.e. the local self-government units, where they are more than 20 percent.

Pursuant to the Constitution of the Republic of Macedonia, Amendment 5 of the Ohrid Agreement 2001:

**On the whole territory of the Republic of Macedonia and in its international relations, the official language is the Macedonian language and its Cyrillic alphabet.**

**Another language is official, as defined in this article of the Constitution, and it is DEFINED IN THIS MANNER:**

Any citizen living in the units of local self-government in which at least 20% of the citizens speak an official language other than the Macedonian language, in communication with the branch offices of the ministries, may use any of the official languages and his / her letter ...

(This means that it must not be done by a state administration body, official, minister, president of the assembly, deputy prime minister or anyone else from a position of state power, especially not on the entire territory of the Republic of Macedonia and on the Macedonians and other ethnic minority communities).

We should bear in mind that the official use of the language of the community exceeding 20% is permitted only in the units of the local self-government and, in a certain way, in the communication with the regional units of the local self-government.

We consider that the language of the minority ethnic community, which is over 20% (whether there are 20 percent, should be determined with an inventory, which has not been conducted since 2001, after the Ohrid Agreement), is used immensely unconstitutionally in boards, autonomous zones, schools, ministries and other institutions, and in communication with the Macedonians and other ethnic minority communities, where according to the Constitution, they are not allowed to stand and impose themselves, contrary to the use of the Macedonian language as a uniting language, ALSO AS a state language that prevents segregation.

It is, also, forgotten that the language of the minority ethnic community, which is over 20 percent, must be used in the local self-government units only in parallel and under the Macedonian language, and only for the members of the ethnic community to which they belong, not for members of other minority communities or Macedonians, and some institutions, and even literary festivals in international use only Albanian as an official language of events.

In this regard, we appeal immediately to stop the violation of the Constitution and the international human rights law, i.e. to stop provocations and requests by the Albanian political leaders in the direction of expanding the use of languages that has no legal or reasonable and logical basis, and causes discord, hatred and intolerance and segregation in the Republic of Macedonia.

Such requests cause riots in the region because they are perceived as territorial pretensions and security threats from all neighbours, because they are in contrast to the Constitution, and finally, quite the contrary, require urgent need of a Law on the Application of the Macedonian Language and the Proper Use of the Languages of All Minority Communities in Local Governments, where an ethnic community that is more than 20% lives.

**We especially condemn such acts because of the fragile internal and external position of the Republic of Macedonia and we perceive it as a form of fascism against the Macedonians and other minority communities in Macedonia, that is, the imposition of the language of two neighbouring countries over the Macedonian population.**

We can no longer ignore the policies by which the state bodies and institutions enforce one of the languages of minority communities or minorities that are considered to be more than 20% (without any official statistics from 2002), Contrary to the Constitution of the Republic of Macedonia and the international human rights law, i.e. to the detriment of the interests of Macedonia, the Macedonians as a nation-state people and other communities, contrary to the Universal Declaration of Human Rights and the principle:

**"Your right must not penalize and violate the circle of my right".**
